## OREGON STATE 600 BOWLING CLUB 2021 TOURNAMENT RULES

1. The **Oregon State 600 Bowling Club Tournament** will be USBC certified. (2021 USBC Certification #04044)
2. Participants must be members of the Oregon State 600 Bowling Club prior to participation, or may pay dues with entry. They must be current USBC members and show receipt of, or have a 2021-2022 USBC card at time of check-in. If none of these, bowler may pay USBC Associate membership fee.
3. This shall be a Handicap Tournament based on 100% of 220.
4. The tournament will consist of a 4-woman Team Event, Doubles Event, Singles Event and an optional All Events. NOTE: MULTIPLE PARTICIPATION will be allowed as follows: TEAM EVENT: Enter as many times as desired but change at least 2 players. DOUBLES EVENT: Enter as many times as you wish but must change partners each time. SINGLES EVENT: Will be limited to one time only. First appearance in each event will count towards All Events. Entrants may enter doubles or singles or both.
5. \*All entrants must use their highest USBC certified average\*\* **2019-2020** Seasons, **or** their highest **2020-2021** Seasons of 21 games or more, including substitute average. Highest Average includes ANY Winter or Summer Certified Bowling). *Please bring verification with you.* USBC Rules 319a2 and 319c, d, & e do not apply. Any bowler not having any of the above will use a scratch average of 220. Failure to use the correct average will disqualify score if submitted average is lower than correct average thereby resulting in more handicap. Prize winnings will be based on submitted average.
6. Substitutes will be allowed, if eligible for the State 600 Club, and will not be required to reimburse the original entrant with entry fee nor will she be expected to give up any prize money and/or award she may win, unless she so desires. A qualified substitute will be allowed in case of an emergency, such as illness or injury during play, if available, in Team or Doubles only.
7. Entrants are not required to report previous tournament prize winnings as condition of entry.
8. ENTRY FEE will be **\$22.00** per event: Lineage \$9.00, Prize Fund \$8.90, Expense Fund \$4.10. All Events (optional) \$3.00 (Prize Fund \$2.00, Expense Fund \$1.00). **NO REFUND OF ENTRY FEES AFTER CLOSING DATE (September 4, 2021).**
9. Prize Ratio will be 1 for every 5 entries in Team, Doubles, Singles and All Events.
10. A late bowler starts in the frame in which she arrives, no frames to be made up.
11. Ladies will **PLEASE WEAR SUITABLE ATTIRE.**
12. In case of a tie for first place, the monies for the number of places tied will be divided equally, with duplicate awards to be given.
13. In case of a lane breakdown, the secretary is granted permission to move the bowlers to another pair of lanes.
14. The Oregon State 600 Bowling Club Board of Directors will have full power to hear and act on all protests arising from or under the construction rules of the Oregon State 600 Bowling Club Tournament. Protests must be confirmed in writing to a Tournament Official before the tournament prize payments are made. Errors in scoring or errors in calculations must be corrected by a responsible Tournament Official immediately upon discovery of such error, with a 24-hour limit. Entrants have a right to appeal any decision of the Tournament Management to USBC in accordance with Rule 329.
15. **NOTICE:** Check-in time is thirty (30) minutes prior to each event.
16. **NOTICE:** The entrants whose names appear hereon, or their authorized replacement, hereby agree that the Oregon State 600 Bowling Club, its officers and agents will be liable only to the extent of returning entry fees if and when these entrants will be prevented from bowling any event in the Tournament which may be brought about by war, national emergency or causes relating thereto or resulting from fires, strikes, labor difficulties or other causes beyond the control of the Oregon State 600 Bowling Club.
17. **NOTICE:** The expense portion of the entry fee includes: Tournament Manager fee, cost of entry forms, prize lists, awards and all other Tournament related expenses.
18. Approved by the Oregon State 600 Bowling Club Board of Directors at the Board meeting held in North Bend on September 7, 2019 and 2020 virtual Board directions, and with revisions, if any, required by USBC.
